POSITION SUMMARY:

Provides direct supervision of a group of children in an after-school camp. Provides a quality experience to children and parents focused on YMCA core values: honesty, respect, responsibility, and caring.

ESSENTIAL FUNCTIONS:

1. Supervises a group of children.
2. Adheres to program standards including safety and cleanliness standards.
3. Maintains proper maintenance on vehicles; such as, fueling, cleaning and regular maintenance upkeep.
4. Attends staff meetings and trainings.
5. Follows YMCA policies and procedures, including those related to: medical and disciplinary situations, child abuse prevention and emergencies.
6. Maintains positive relations with parents and other staff. Models relationship-building skills (including Listen First) in all interactions.

YMCA COMPETENCIES (Leader):

Mission Advancement: Accepts and demonstrates the Y's values. Demonstrates a desire to serve others and fulfill community needs. Recruits volunteers and builds effective, supportive working relationships with them. Supports fund-raising.

PHYSICAL DEMANDS

1. Adequate mobility, sight and hearing to effectively supervise program participants.
2. Sufficient strength and agility to perform essential functions of position including the ability to lift a child who weighs approximately 50 pounds.
3. Ability to perform essential functions which may involve, but not limited to the following activities: standing; sitting; semi-to-full reaching overhead; crouching; kneeling; carrying; twisting of the waist, shoulders and legs.
4. All staff are required to wear a face mask indoors, daily temperature reporting, and maintain social distancing whenever possible.
